To adopt / apply the best practices of world in saving life of citizen of NCT of Delhi and loss prevention by enforcing codes and standards under statutory provisions, deploying & responding emergency vehicle for citizen in distress conditions under fire, imparting fire safety awareness and education programs by trained / skilled professionals and inculcating fire safety culture with optimum utilization of resources & sustained efforts.

## Business Transected Delhi Fire Service

- To provide immediate response to every fire and emergency call. (Citizen can dial 101 for availing this service in distress condition)
- To provide fire prevention services for upcoming and existing buildings identified as class of occupancies likely to cause risk of fire under DFS Rule 2010.

(To avail this services applicant can apply to this department through building sanctioning authorities along with building plans in prescribed scale and Performa's. Guidelines will be issued within 21 days from the date of approval by FPW committee)

## Business Transected Delhi Fire Service

### To provide standby services of fire units against payment.

(To avail this services applicant can apply in prescribed Performa in Form-B (see Annexure) and submit application at Dak/ Receipt Counter, First Floor, HQ; Delhi Fire Service, Connaught Place. This is subject to availability of fire units) Charges for availing the services are Rs. 5000/- for six hours, 10,000/-for twelve hours & 20,000/- for 24 hours.

#### Erection of Pandal.

Erection of pandal is self regulatory under Rules 2010 and applicant after erecting the pandal in conformity with requirements under rule 29 of the Delhi Fire Service Rules, 2010 must place the Form-D (see Annexure) at conspicuous place.

#### APPLICATION FOR GRANT OF FIRE SAFETY CERTIFICATE

Applicant seeking grant of fire safety certificate can apply in Form -I (See Annexure) at Dak/ Receipt Counter, First Floor, HQ; Delhi Fire Service, Connaught Place, New Delhi.

### APPLICATION FOR RENEWAL OF FIRE SAFETY CERTIFICATE

Applicant seeking grant of fire safety certificate can apply in Form-J (See Annexure) at Dak/ Receipt Counter, First Floor, HQ; Delhi Fire Service, Connaught Place, New Delhi.

### DECLARATION BY OWNER/OCCUPIER

Occupier/ owner/ fire safety officer of the building or premises shall declare every year in Form-K (see annexure) that fire prevention and fire safety measure provided in the building or premises as the case may be are in best repairs.

#### APPEAL

Any appeal to the Appellate Authority under sub-section 7 of section 27 of Act can be applied in Form-R (see annexure) along with copy of order or notice appealed against and a fee of Rs. 5000/- through bank draft drawn in favour of DDO (Head quarters) at Dak/ Receipt Counter, First Floor, HQ; Delhi Fire Service, Connaught Place, New Delhi.

#### FIRE REPORT

Fire report can be down loaded from official website of Delhi Fire Service www.dfs.delhigovt.nic.in within 72 hrs of occurrence free of cost. In case of any discrepancy in fire report, applicant can apply in Form-T alongwith supporting document for change report at Dak/ Receipt Counter, First Floor, HQ; Delhi Fire Service, Connaught Place, New Delhi.

# Expectation from the client by the department

- Report every incident of fire, rescue immediately to fire control room (101) (provide correct information)
- Give way to right for fire units responding on emergency calls.
- For desired services apply on prescribed Performa as mentioned in Delhi fire service Rule 2010.
- Consult fire department for the new constructions which are covered under Delhi Fire Service Act 2007 and Rule 2010.
- Follow the provision of Delhi Fire Service Act 2007 and Rule 2010.
- Ensure Fire safety norms and obtain fire safety certificate.
- Avoid unauthorized construction, encroachments on roads, unauthorized parking to ensure free movement of fire tenders.
- Learn operation of fire safety equipment and ensure their operability.
- Ensure safety of fire protection equipment; avoid theft and damage to fire safety equipments.
